Whereas the petition abovementioned has been preferred by the petitioner above named to this Court against, Memo dated 08.04.2018 regarding activities for formation and constitution of Managing Committee of primary schools at Chakoria Upazilla under Cox's Bazar district for the year 2018 without specifying any specific date of election under Table Serial No. 10 as "আলোচনা সাপেক্ষে নির্ধারন করা হবে" issued under the signature of the respondent No. 6 (Annexure-C). AND Election Schedule dated 16.04.2018 for formation and constitution of Managing Committee of the respondent No. 7 school at Chakoria Upazilla under Cox's Bazar district without specifying any specific date of election under Table Serial No. 06 with inserting comment "আলোচনা সাপেক্ষে নির্ধারন করা হবে" issued under the joint signatures of the respondent No. 6 and 8 (Annexure-D).

Now upon hearing Mr. Mir Mohammad Nasir Uddin with Mr. Mohammad Mujibur Rahman, Advocates For the petitioner. Mr. Md. Ekramul Hoque, DAG with Ms. Purabi Rani Sharma, AAG and Ms. Purabi Saha, AAG For the respondents, and upon consideration of the said petition this Court doth order and do issue a Rule Nisi calling upon you the aforesaid respondents to show cause on or before the 29th July, 2018 as to why the Memo dated 08.04.2018 issued under the signature of the respondent no. 6 (Annexure-'C' to the Writ Petition) and the election schedule dated 16.04.2018 issued under the signature of the respondent no. 7 (Annexure-'D' to the Writ Petition) relating to the constitution of the Managing Committee of Mobinpara Ausus Government Primary School at B.M. Char Union, Upazilla Chakoria, District Cox's Bazar for the year 2018 without specifying any date of election should not be declared to be without lawful authority and of no legal effect and/or such other or further order or orders passed as to this Court may seem fit and proper.

Subject to the disposal of the Rule, let the operation of the impugned Memo dated 08.04.2018 issued under signature of the respondent no. 6 (Annexure-'C' to the Writ Petition) and the election schedule dated 16.04.2018 issued under signature of the respondent no. 7 (Annexure-'D' to the Writ Petition) be stayed for a period of 6(six) months.

The petitioner is directed to put in requisites for service of notices upon the respondents by registered post as well as through usual process within 3(three) working days, failing which, the Rule shall stand discharged.
